Fibre Drinking straws (reusable) under the trade names "EUROSTRAWS" in colours Natural and Black.

comply with the requirements of Act No. 258/2000 Coll., on the protection of public health, Decree of the Ministry of Health No. 38/2001 Coll., on the hygienic requirements for products intended to come into contact with food and foodstuffs, Regulation (EC) No. 1935/2004 of the European Parliament and of the Council on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Commission Regulation (EC) No. 2023/2006 on good manufacturing practice for materials and articles intended to come into contact with food, and Commission Regulation (EU) No. 10/2011 on plastic materials and articles intended to come into contact with food. (Hereinafter only the "Regulation")

Material composition: 60 - 70% compostable aliphatic copolyester
30 – 40% mineral filler (food-grade talc)
0-2% lubricant based on modified biobased fatty acids
0-10% highly purified food-contact approved cellulose fibres

Euro Straws further states that the products do not contain the following:

PLA
BPA
GMO materials
Plasticizers

With regard to the results of the tests on drinking straws presented below, no information obtained from laboratory tests has shown any information which shows that any substances subject to certain restrictions in food as regards their specific migration level and, where appropriate, purity criteria exceeds the allowable limits according to relevant Directives. (Point 7 of Annex IV to the Regulation)

This is not a multi-layered product and there is no functional barrier used in the product.
